Smith, a former client of his at Squire Patton Boggs; Greene is responsible for overseeing the company's legislative, regulatory, and industry initiatives, including administration of its PAC, as well as monitoring and influencing legislation at the federal, state, and local level that impacts A.O. Smith and the water heating and treatment industry, including issues such as water heating's role in demand response programs and regulatory standards for contaminants in drinking water

Combines practical, legal, business, and legislative knowledge concerning sustainability at both the federal and state level; believes in fostering innovation by engaging the private sector and lifting up minority entrepreneurs

- As a business founder raised in a family of entrepreneurs, Greene saw the practical, private market side of regulatory policy in energy and environment, which informs his approach to government affairs and drives his support for entrepreneurship incubator programs
- Views fostering entrepreneurship as a crucial step in moving towards establishing a more sustainable and circular economy and job creation; says that governments can provide important venues by which entrepreneurs can experiment and come up with promising solutions
- Says that cleantech technologies not only do a public and environmental good but also make strong business cases
- Informed by his client work at Squire Patton Boggs, Greene gained a deep knowledge of the legal side of energy and environmental policy; and leverages this when working with corporate development leaders at A.O. Smith on new business opportunities
- Believes that diversity leads to more innovation and advocates greater investment in communities of color and amongst women, including early education STEM programs, mentorship, and accelerator programs; views outreach to "the right" organizations, such as historically black colleges and universities, as crucial to building diversity in the energy space
